Client Consent on the Personal Information Collection Statement and Undertaking of updates on Client Identification Data in connection to the Investor Identification Model and OTC securities reporting

有關投資者識別碼模及場外證券匯報個人資料收集聲明及承諾更新客戶識別信息之客戶同意書

The terms Broker-to-Client Assigned Number ("BCAN") and Client Identification Data ("CID") stated below shall bear the meanings as defined in paragraph 5.6 of the Code of Conduct for Persons Licensed by or Registered with the Securities and Futures Commission. Other capitalized terms used below shall have the same meanings as defined in the Rules of the Stock Exchange of Hong Kong Limited ("SEHK"). If there is any inconsistency or ambiguity between the English version and the Chinese version, the English version shall prevail. 以下段落所述的券商客戶編碼及客戶識別信息具有《證券及期貨事務監察委員會持牌人或註冊人操守準則》第 5.6 段所界定的含義。以下段落使用的其他術語,與香港聯合交易所有限公司(「**聯交所**」)規則內的術語具有相同的含義。如中、英文兩個版本有任何抵觸或不相符之處,應以英文版本為準。

SFC) so as to facilitate the performance of their statutory functions with respect to the Hong Kong financial markets; and (iii) use such information for conducting analysis for the purposes of market oversight; and 允許聯交所: (i) 收集、儲存、處理及使用本人/吾等的個人資料(包括客戶識別信息及券商客戶編碼),以便監察和監管市場及執行《聯交所規則》; (ii) 向香港相關監管機構和執法機構(包括但不限於證監會)披露及轉移有關資料,以便他們就香港金融市場履行其法定職能;及(iii) 為監察市場目的而使用有關資料進行分析;及
